This Certificate issued subject to the following conditions.

1. This registration is under subject to Section 3(5)(4)
2. Strictly follow all the conditions mentioned under Section 4(4) by the Governing Council
3. Subject to the conditions that to provide the financial advantages for School Site, Extent, Building study Furnitures, Staff.
4. Open the school in the medium for which it is sanctioned and in the same place also not allowed to change of place under any circumstances.
5. Run in the same name and in same place from the same administrative Boards by the administration board for which the licence issued and not to transfer without prior permission from the Government/Department under any reason.
6. This educational institutions must follow all the orders and rules of the Government which are passed or to be passed from time to time regarding the educational institutions.
7. Implementation of Text and book, examination etc., as prescribed by the Government and the Department.
8. To get renewal of the approval from the concerned officers within three months from the date of registration of school.
9. Follow up of rules to maintain the ratio of the children and teachers in each classes as permitted.

10. Must recruit only trained and eligible educated teachers to the school as per the rules of the department and strictly it is necessary to provide service Securities to the Teachers and to the Staff.
11. As per rules Medical examinations to be made to the students in every year.
12. Must to provided the School site, in the name of Institution, Building, Furnitures, study furnitures, Library Books, Play Ground, School building etc., facilities within One Year, otherwise the registration will be cancelled under rules of the Karnataka Education Act.
13. Follow the rules during the School Working Hours and days.
14. Submit an Affidavit sworn before Notary stating to run the school from 1st standard to 8th standard in Kannada Medium/Mother tongue language as present language policy.
15. Regarding opening of the school and student's enrollment should be intimated within two months from the date of registration of the school or from the date starting of educational period. If not opened the school or not followed anyone of the conditions, then this order is automatically cancelled.
16. Under any circumstances, without the prior permission from the government not to open more divisions by the school.
17. All the Schools registered Under Section 36-37 of Karnataka Educational Act Annexure 8 will be comes under the limit of Recognition and Provisional Recognition.
18. Follow the rules 1999 of the Karnataka Private Educational Institutions (Private Aided Primary and Higher Educational Institutions employees recruitment, Service condition and regulations) without default.
19. For opening of the school , the institution should be deposit the Security Deposit in the Nationalized Bank in joint account of the Block Education Officer, Public Education Department, Bangalore South Zone-1 and Secretary of the Administrative Board.
20. In the School separate Toilets must be provided to the Girls and boys and to provide Drinking Water facilities.
21. Make necessary arrangement with safeguard of the Students, Teachers and to the Staff, during the Fire, hazards storm to the building safety. Regarding building safeguard should follow the Direction as issued by the Supreme Court in case No.483/2004, dated 13-4-2009.
22. Enrollment will be get started after 10th April in every year. Strictly follow the reservation rules of the Government and preference may be given to the local peoples.
